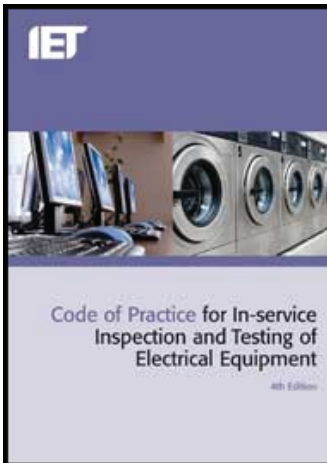

It also allows those with an administrative responsibility for the testing and inspection of electrical equipment to gain a qualification suitable to their job role, such as those self employed operatives taking responsibility for both the 'hands on' and 'administration/audit trail functions' etc.
